
About the Acquisition

Pricing Models

- **Subscription Pricing:** Addresses the combination of expertise, technology, and time applied to address specific needs and is typically quantified by pre-agreed tasks that are accomplished for a particular time frame at fixed and tiered rates that are usually lower than traditional project pricing rates.
- **Traditional Project Pricing:** Addresses the combination of expertise and technology applied to complete specific tasks and is typically quantified by the time or volume consumed or acted upon in the completion of agreed-upon tasks.

The four primary offering categories and three proven pricing models will be the basis for the combined company's client engagement through its traditional sales, business development, and account management efforts and through four consulting-centric practices.

- **4.** The need to **review and produce** ESI to help customers achieve their legal, informational, and business objectives.


