#### **Risks and Consequences of Sticking with Manual Efforts**

The risk of sanctions and other harmful consequences typically arises from the failure to establish and maintain a repeatable and defensible legal hold program, leading to the deletion of potentially responsive ESI for litigation.

#### Judges have imposed Orders which:

- Direct that specific facts be taken as established.
- Prohibit the disobedient party from supporting or opposing specific claims or from introducing certain matters into evidence.
- Strike pleadings in whole or in part.
- Dismiss the action in whole or in part.
- Render a default judgment against the disobedient party.
- Impose monetary fines on the lawyers and/or clients.
- Give adverse jury instructions.
- Exclude evidence if the court later concludes relevant evidence was destroyed in bad faith.
